Dear Parents

### **SCHOOL FEES AND RE-REGISTRATION FOR 2012**

#### **1. SCHOOL FEES**

During a parent's meeting held on Wednesday, 14 September 2011, the school fees for 2012 were set at R6 000.00 per learner per year. I assure you that this matter was handled in the most cautious ways. Measured against all standards, the SGB is satisfied that the quality of education your child receive at Laerskool Thabazimbi is good value for money.

- School fees amount R6 000.00 per learner per year.
- First installment of R600.00 is payable WITH re-registration for 2012 and please note that this installment is not refundable.
- A signed debit order for Amandelbult Mine or Northam Platinum Mine will also be accepted as first payment.
- A reduction of 7,5 % is granted for those who pay their school fees in full by 31 January 2012.
- A reduction for households with more than one learner in Gr 1 – 7 in Laerskool Thabazimbi the school fees are calculated as follows:

<b>LEARNER 1</b>	<b>-</b>	<b>R6 000.00</b>
<b>LEARNER 2</b>	<b>-</b>	<b>R5 700.00 (5 % REDUCTION)</b>
<b>LEARNER 3</b>	<b>-</b>	<b>R5 400.00 (10 % REDUCTION)</b>
<b>LEARNER 4</b>	<b>-</b>	<b>R4 800.00 (20 % REDUCTION)</b>

- We request that parents/guardians use a debit order as means of payment.
- Parent/Guardian who pay cash, must ensure that the full amount of the school fees for 2012 is payable before/on Friday, 5 October 2012.
- Please take note that school fees are paid in advance. (The amount for January 2012 must be paid before 7 January 2012 etc.)

2. **RE-REGISTRATION**

To ease this process we friendly request the following. Please fully complete the re-registration and agreement form for 2012 and send it back to your child's class teacher before or on Friday, 23 September 2011.

Re-registration is a privilege for currently enrolled learners subject to the following conditions:

- First payment for 2012 payable with registration;
- Satisfactory academic performance;
- Satisfactory behavior in accordance with the school's Code of Conduct;
- **Fully paid school fees for 2011, or the necessary arrangements have been made with the SGB for exemption reduction or a settlement date for payment.**

If we do not receive the necessary forms back on Friday, 23 September 2011, we shall assume that the family has plans to relocate or that the learner will enroll at another school.

**This means that your child will not register for 2012 and will not be placed on a class list for 2012.**

3. **EXEMPTION OF SCHOOL FEES FOR 2012**

If you would like to make use of the above-mentioned option, we urge you to attach the completed form to the re-registration form. The forms are available at the Administration Office.
